



Respite Care

Respite is available for temporary and emergency housing to ensure an individual's health and safety. Use of respite care is based on an individual's abilities and specific criteria apply. Contact your SSA for more information.

ELIGIBILITY

State rules require CLS staff to determine if your family member is eligible for services. You will need to provide the most recent school, medical and psychological records to prove your family community employment to assist individuals in living, working and participating in the Clark County member's disability. An Intake Specialist will then meet with you and your family member to determine eligibility.

Eligibility is redetermined at ages 3, 6, and 16. This means your family member may qualify for services during different points in his/her life.

COMMUNITY LIVING SERVICES

- Community Living Services is a department of Developmental Disabilities of Clark County that assists people age three and up* in transitioning through their life stages.
- We help people with developmental disabilities explore community services and advocate to safeguard their rights.
- We also work closely with agencies and organizations that provide care for people who receive services.
- We are funded by the Developmental Disabilities of Clark County levy, and Federal and State resources.

WHAT IS A DEVELOPMENTAL DISABILITY?

A developmental disability is a severe, chronic disability mental and/or physical impairment. It occurs before age 22, and is likely to continue indefinitely and it results in substantial limitation in at least three areas of life, including: self-care, language, learning, mobility, self-direction, and capacity for independent living. Common conditions resulting in a developmental disability include Down syndrome, cerebral palsy, and autism spectrum disorders.

SERVICES

Person-centered Planning

Individuals receiving services are assigned a Service and Supports Administrator (SSA) who serves as their primary point of coordination.

Ages 3 to 15: SSAs work with families and children as they advance through the educational system. SSAs also link families to community services such as summer camps.

Ages 16 to 22: SSAs support young adults' transition from school to community employment and living opportunities.

Ages 23 and above: SSAs work with adults by linking to other agencies such as adult day programs or community.



Individual Service Monitoring

We assure that services are being delivered according to the individual's plan and in accordance with policies.

Crisis Intervention

We provide emergency services to eligible individuals on a 24-hour basis. Our emergency number is 937-215-6983.

Information and Referral

We respond to questions and requests from individuals in the community regardless of their eligibility for services.

An SSA works with each person to identify goals, needs, and resources necessary to maintain and enhance health, safety and welfare.
