# Early Childhood

Serving children age birth to five. 50% of children in this program no longer need services upon entering kindergarten.

## Health and Welfare

Staff monitor and investigate situations in order to maintain safe living conditions for individuals.

## Transportation

Specially adapted buses and vans transport individuals to work and community sites.

Quality training for partner agencies to help them attain certification from the state.

# DEVELOPMENTAL DISABILITIES OF CLARK COUNTY

- Since the early 1960s, we have provided information, support, and services for people with conditions like intellectual disability, autism, Down syndrome, cerebral palsy, or traumatic brain injury.

We currently assist over 1,100 Clark County residents throughout their lives with funding, support, safeguards, and connections with partner agencies.

We depend on county levy funds for 69% of our budget\*, with the remaining dollars provided by the State and Federal government. We seek every opportunity to collaborate with other organizations and businesses, and intensively pursue grants at every opportunity.

# WHAT IS A DEVELOPMENTAL DISABILITY?

A developmental disability is a severe, chronic condition that begins any time from birth through age 21, and is expected to last a lifetime. It can result in serious limitations in everyday activities of life, including self-care, communication, learning, mobility, or being able to work or live independently.

# WHO WE ARE

Developmental Disabilities of Clark County has been serving our community for over 60 years. Our mission is to empower people who have developmental disabilities to achieve their fullest potential. Much of what we do takes place in the community, where individuals with developmental disabilities live, work, and participate as everyday citizens.

Our primary functions are as an administrator, funder, and service provider. We

- determine who is eligible for services,
- are responsible for the safety and security of people who have DD in Clark County,
- seek, secure, and distribute Federal, State, and local funds to pay for services, and
- offer quality services in addition to contracting services with certified provider agencies and individuals.



### We provide:

- support for children and adults too costly for families to afford.
- long term care when family can no longer provide support.
- support for people who are severely disabled.
- job and living skills training to help individuals become selfsufficient.

As of 2019, approximately four million Americans have developmental disabilities. 17% of children age 3-17 have a developmental disability and that number continues to grow.
