Then it was time to construct the document with various timelines and rules. After a couple of months, we have the finished document. It was a great experience to have all players at the table contributing and working together for the children and families we serve.

One of our Service and Support Administrators has been working tirelessly on a new Exit Waiver that has been awarded to a little 2-year-old coming out of an ICF. Typically, we do not have waivers in Early Childhood so this was going to be a process. Fortunately for us, Renae has worked with waivers before when she worked with adults at CLS prior to coming to Early Childhood so we were not starting from scratch. This little boy will be going home to live with his grandmother and grandfather at the end of January and to say the celebration will be a joyous one is an understatement. Thanks to Renae for bringing this dream to reality for this family.

We received the email we have been waiting on that the ARPA funds for Early Intervention has been approved. The full amount of \$76,000 will be spent on continuing to deliver Evidence Based services with new technology and trainings for the staff. Ravi, Christy and I put in quite a few hours to get this accomplished. Thanks to Ravi and Christy as you are always supporting us.

stop by and see Marty they can sign up for a chance to win free movie tickets. In January we will be seeing Spiderman.

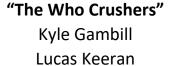
#### **Community Calendar**

# **Operations Department**

#### **FACILITIES MAINTENANCE**

- We are preparing for 2022 Capital Improvement projects by setting project timelines and receiving quotes from contractors.
- Once the Commissioners approve the budget, we will begin inside projects.
- We are reviewing maintenance and service contracts to determine which should be renewed or terminated.
- We continue to treat all work areas, the cottages and sunset units, with the disinfectant QT3 as needed. We have placed portable hand sanitizers and disinfectant stations in each building. Employees are required to wipe down their work area at the end of the day.

#### TRANSPORTATION

• The Drivers started 2022 on the new routes they selected last December in accordance with the Teamsters Union contract.

• We are now transporting 23 individuals to community employment daily. We expect ridership to continue going up and down with the COVID.
