- ❖ Early Childhood is part of Developmental Disabilities of Clark County. We provide services for children ages 3 to 5.
- ❖ We work with your child's school and community partners to assist with resources.
- ❖ Our commitment is to provide quality services for your child and family. We partner with you to promote your child's participation in daily activities. Parent involvement is crucial in all aspects of the child's success.

WE ARE EXPERTS

Our team is made up of service and support administrators. Each team member has experience working with children who have a variety of needs, including hearing and vision loss, Autism, language delays, Down syndrome, limited mobility and more.

We will help support your family as you navigate the school system while becoming your child's advocate.

Early Childhood is funded by the Developmental Disabilities of Clark County levy and State grant funds.

WHAT TO EXPECT

Once your child has been referred to our program, he/she will be assigned a Service and Support Administrator (SSA) who will assist you through the IEP process and help locate resources.

ELIGIBILITY

Children age 3-5 are eligible for services if they have a:

- diagnosed disability
- 2 areas listed in an IEP

Eligibility is redetermined at age 6. This means your child may qualify for services during different times in his/her life. For a child age 3-5 call Early Childhood at (937) 328-2680.

Having an SSA to reach out to has been so helpful. When I needed information or resources, she helped me find answers quickly. When I was feeling down, she was there to give me a pep talk and point me in the right direction.
